1. Melissa Hudson briefly reviewed the methods and progress accomplished by the IGHG **(see attached slide file labeled “IGHG Intro Memphis 2013”)**.
2. Hamish Wallace summarized the progress of the female gonadal toxicity surveillance harmonization. He reviewed the discordant recommendations from previously published screening/surveillance guidelines. The group discussed the focused clinical questions for evidence summaries and the preliminary results and limitations of the search strategies **(see attached slide file labeled “IGHG Female Gonadal Toxicity Harmonization Memphis 2013”)**.
3. Rod Skinner summarized the progress of the male gonadal toxicity surveillance harmonization. He reviewed the discordant recommendations from previously published screening/surveillance guidelines. The group discussed the focused clinical questions for evidence summaries and the preliminary results and limitations of the search strategies. **(see attached slide file labeled “IGHG Male Gonadal Toxicity Harmonization Memphis 2013”)**.
4. Leontien Kremer presented the template for the IGHG Website that will be developed with the support of PanCareSurFup. The website will include links that will provide information about harmonization meetings, guideline methods and resources, surveillance/screening topics, working groups, and publications. A goal is to develop interactive and educational features as well. **(see attached slide file labeled “IGHG website Memphis 2013”)**.
5. Future guideline topics according to the Delphi survey include coronary artery disease, CNS malignancies and growth hormone deficiency. The IGHG core leadership group will conference call to discuss potential expert panel chairs and members related to these topics.
6. Potential options for the next meeting venue were discussed. A meeting will most definitely be convened in concert with the European Symposium on Late Complications after Childhood Cancer in Edinburgh, UK scheduled September 15-16. The group agreed that organizing a meeting earlier in 2014 is critical to maintain timely progress in completing the gonadal toxicity screening harmonization and initiating new harmonization topics.
